Purpose of loan	The loan is needed to prepare for an influx of baby places starting in September. To accommodate this, they need to create more space at both sites by renovating old cloakrooms and clearing out dead space. This expansion is essential to capitalize on the new government funding scheme that offers £10.40 per hour for baby care, rather than £5 per hour for other aged children. This scheme for kids from 9 months old, is aimed at encouraging mothers to return to work and they want to grow the turnover by taking on more babies.
