Just to confirm the end of day balances never enter into an unarranged overdraft.

If we are ever showing as 'overdrawn' it is early in the morning on an account and once I have done the banking I always transfer funds by 12 noon to make sure we are in credit.

Because I keep our surplus cash on deposit earning interest rather than in our current accounts earning no interest some banks can show you as 'overdrawn' in the morning. However I do always transfer funds whenever required on any day so that we are never 'overdrawn'.
